FULL ACTIVE MEMBERSHIP: Dues for 2021-22. Our fiscal year runs from July 1 - June 30.

This is a voting membership and also allows you to advertise your trees/wreaths on the WCTPA website. Active membership shall be for persons or firms engaged in producing or marketing Christmas trees, wreaths, boughs and roping/garland in or from Wisconsin or Upper Peninsula Michigan. Dues amount is based on your gross income of these items from the previous season.

Included in the dues payment is:

- ▶ A \$25 Tree Industry Partnership (TIP) assessment which goes to the National Christmas Tree Association, used for industry protection and other benefits.
- ▶ Subscription to the *Great Lakes Christmas Tree Journal*, mailed directly from them.

Trees for Troops

This is your chance to donate to the Trees for Troops program. The Christmas Spirit Foundation (charitable branch of the National Christmas Tree Association) coordinates the collection and distribution of trees donated by Christmas tree growers and given to military families throughout the U.S. This program generates a lot of good will for us along with media attention.

In Wisconsin we will tentatively have 3 collection points: Green Bay, Wausau and Madison. The collection date has typically been the Monday, Tuesday or Wednesday after Thanksgiving. Growers bring their trees to the collection point to be loaded

onto a FedEx truck. Our goal is 600 trees. Please indicate on the payment form and let me know by July 15th if you are donating trees.

Monetary donations are appreciated to offset the cost to run this national program.
